


Exhibit Hall Location

Exhibit Hall C is in the North End of the Convention Center, as indicated on the above map. You will need to use **Dock 19** behind Hall B to load and unload.

The most convenient parking location is the Goodale Garage, which is directly across from Exhibit Hall D.

Set Up and Dismantling Times:

Set up: Monday, April 11 between the hours of 11:00 am - 2:00 pm

Tuesday, April 12 hand-carry items 7:30 am - 8:30 am

Move out: Tuesday, April 12 - 12:45 pm to 4:00 pm

Special arrangements must be made with the decorator for Friday pick up.

The Expo hours:

Monday, April 11 - 4:30 pm - 6:30 pm Tuesday, April 12 - 9:30 am - 12:45 pm

Exhibitor Badges

Booth fees include <u>two</u> name badges. Badges will be on hold under your company name and may be picked up at the Registration Counter at Room C160 on Monday, April 11, beginning at 3:00 pm. Additional name badges/passes may be purchased in advance online or onsite at the Registration Counter at \$50.00 per badge.

Exhibitor badges give you access to the Expo for MONDAY AND TUESDAY ONLY.

Exhibitors wanting to attend track sessions, general sessions, luncheons, receptions, or

the Tuesday night party must register separately as a conference attendee, or purchase a ticket to the luncheon or party online in advance or at the Registration Counter

Show Decorator: Fern Company

OASBO provides you with a draped booth space. In January, Fern Co. will send you a Customer ID and a password code so you can access the online forms to order any items needed for your booth display (such as tables, chairs, carpet, etc). Due to safety and liability issues, exhibitors may not begin dismantling or moving out until 12:45 p.m. Any exhibitor failing to comply may be subject to penalties including, but not limited to, loss of booth preference or exhibiting privilege.
