- Applicants will be interviewed by the nominating committee by conference call.
- Applicants will be notified of the time of the interview, of the members of the nominating committee and the number of applications received.
- The nominating committee will make final decisions and notify each of the applicants of those decisions within a week of the interviews.
- The committee will make the recommendations available to the membership in April.
- Notifications to the membership will include the spring *SBO Quarterly* and other media.
- A recommended slate of officers will be presented to the membership for consideration at the April 2018 Annual Workshop.
