Chapter Incorporation

This is going to be a busy year for NWOASBO officers as we incorporate our chapter. August 9-11, Amy Gioffredo and I were able to take part in OASBO's Leadership Retreat as representatives for the Northwest Chapter. One of the items discussed was chapter incorporation. You may have read Jim Rowan's recent article in the SBO Quarterly discussing the issues surrounding the current chapter structure.

To resolve the issue, there are two choices presented to each chapter: incorporate or dissolve. Over the next year, the officers will be fulfilling the requirements presented to us in order to incorporate and keep our chapter intact. The documents required for incorporation are currently being reviewed for feedback until September 30. These documents will be the same for all chapters that wish to incorporate. OASBO anticipates all bylaws and legal documents being finalized by October 31. Chapters will have until July 1, 2018 to file completed documents of incorporation to OASBO.

that would identify the OASBO approved name for the incorporated chapter; authorize the officers to act as incorporators; determine the number of directors to serve on the board; appoint the initial directors of the incorporated chapter, approve the expenditure of the filing fee for the initial articles, and approve the filing of the "Initial Articles of Incorporation" with the Ohio Secretary of State. We will be looking to do this at the winter meeting.

Steps two and three of the process are to hold an initial meeting of the incorporators (current officers) to approve the chapter's by-laws, elect the officers of the incorporated chapter, and authorize those officers to take the actions necessary to finalize the incorporation process with OASBO. This will have to be done within 90 days of the first step being fulfilled.
