Greater Columbus Convention Center, **Exhibit Hall C** | Columbus, Ohio

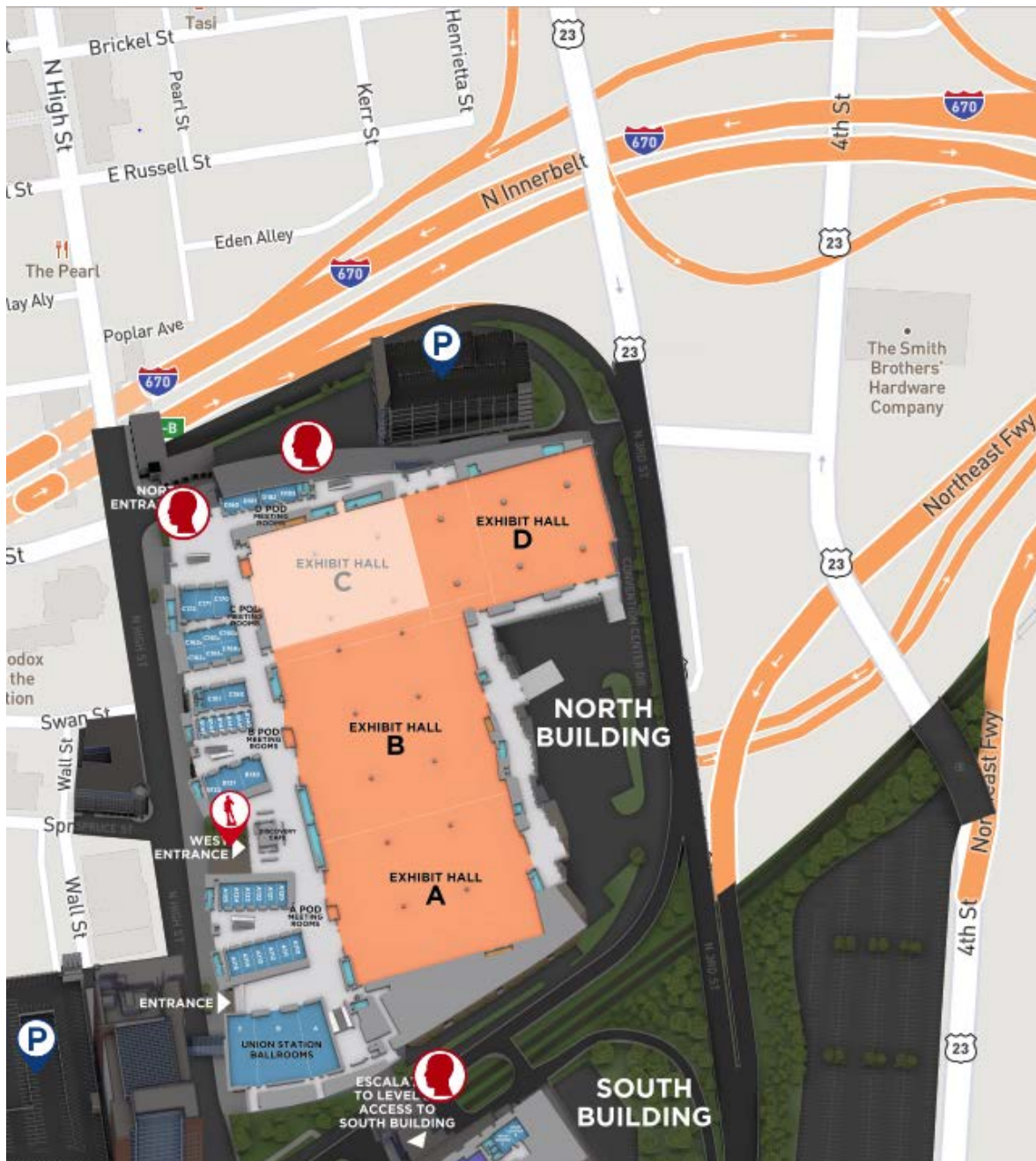


Exhibit Hall Location

Exhibit Hall C is in the North End of the Convention Center, as indicated on the above map. You will need to use **Dock 19** behind Hall B to load and unload.

The most convenient parking location is the Goodale Garage, which is directly across from Exhibit Hall D.

Set Up and Dismantling Times:

Set up: **Wednesday, April 24** between the hours of **3:00 pm - 7:00 pm**
Thursday, April 25 hand-carry items **7:30 am - 8:30 am**

Move out: **Thursday, April 25 - 3:30 pm to 7:00 pm**
Special arrangements must be made with the decorator for Friday pick up.

The Trade Show hours:

9:30 am – 3:30 pm Trade Show Hours

9:30 am – 10:30 am – Dedicated Trade Show Time (no other events taking place)

11:30 am – 1:00 pm – Dedicated Trade Show Time (**New in 2019 - Trade Show Luncheon**)

2:15 pm – 3:15 pm – Snack Break in Trade Show / Drawings and Giveaways

Exhibitor Badges Booth fees include two name badges. Badges will be on hold under your company name and may be picked up at the Registration Counter at Room C160 on Thursday, April 25, beginning at 7:30 am. Additional name badges/passes may be purchased in advance online or onsite at the Registration Counter at \$50.00 per badge.

Exhibitor badges give you access to the Trade Show and track sessions for THURSDAY ONLY. ***Exhibitors wanting to attend track sessions, general sessions, luncheons, receptions, or the Wednesday night party must register separately as a conference attendee***, or purchase a ticket to the party online in advance or at the Registration Counter

Show Decorator: Fern Company

OASBO provides you with a draped booth space. Within a few days of purchasing your booth space, Fern Co. will send you a Customer ID and a password code so you can access the online forms to order any items needed for your booth display (such as tables, chairs, carpet, etc). All exhibits must remain in place until 3:30 p.m., Thursday, April 25, at which time dismantling may begin. Due to safety and liability issues, exhibitors may not begin dismantling or moving out until 3:30 p.m. Any exhibitor failing to comply may be subject to penalties including, but not limited to, loss of booth preference or exhibiting privilege.
